### **INFRASTRUCTURE**

MNLU Mumbai completed its first two years at the renowned Tata Institute of Social Sciences, Mumbai and continues the journey at its new campus at the prestigious CETTM (Centre for Excellence in Telecom Training and Management) located in Hiranandani Gardens, Powai, Mumbai. This is one of the biggest telecom training centres in Asia. The campus location is proximate to IIT Bombay and 13 km from Chhatrapati Shivaji International Airport. The current campus spaces of the university in the sprawling CETTM tower are four floors admeasuring 46298.10 sq.ft.

The University shares various facilities with this distinguished institution. The Academic block has classrooms designed in cafeteria style to foster a culture of active learning and participation. Furthermore, there is a fully equipped Moot Court Hall, Conference Hall, Mediation Centre, Legal Services Clinic, Internship Cell and much more, with the possibility to meet the demands of traditional learning.

The University is also granted a fully furnished hostel with more than one hundred rooms in the residential block of CETTM Training Hostel situated just across the road. The Residential Block includes fully furnished and spacious double-seater hostel rooms with balconies. The hostel complex features a sprawling lobby, recreation room and area for a variety of sports. ### Explanation:

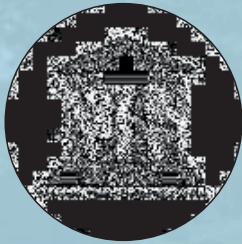
- I. Letter grades O, D, A++, A+ A, B+, and B in a course means that the candidate has passed that course.

- iv. A student will be eligible for the award of B.A., LL.B. (Hons.) degree only when he/she has successfully completed all the prescribed 55 or more courses with a total of minimum 220 credits and obtained a CGPA 4.5 or more out of 8.00.

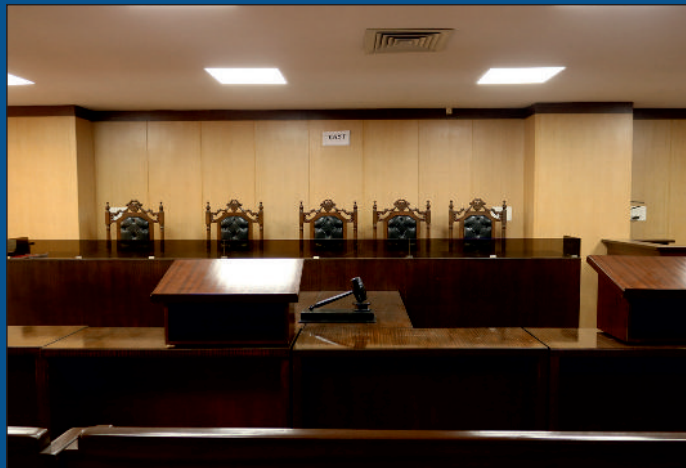
## Sports Association

## **STUDENT AND UNIVERSITY INITIATIVES**

### **Centre for Arbitration and Research (CAR)**

CAR seeks to serve as a think-tank to generate awareness about arbitration law in theory and in practice and also carry out high quality research in the field to assist policy-formulation by the Government. The Centre also intends to serve as a platform for imparting professional training to the stakeholders in the field of arbitration and cater to all areas of arbitration with a special focus on niche areas such as sports arbitration, construction arbitration, maritime arbitration, etc.

### **Centre for Information Communication Technology and Law (CICTL)**

CICTL aims to be a centre for excellence in generating and disseminating knowledge concerning the interrelationship between technology and law across the globe. One of the main objectives of the Centre is to bring together experts, leaders and researchers from the technical and legal domain and to undertake, promote and disseminate core law and policy research in the techno-legal field.

### **Centre for Maritime Law and Research (CMLR)**

CMLR conducts training programs, conferences, workshops and seminars in the field of maritime law & insurance. It aims to address the concerns of the shipping industry, seafarers, maritime insurance and also coastal security.

### **Justice M. L. Pendse Chair in Environmental Law**

The Chair initiates, plans, implements and conducts follow-up research activities exclusively in the area of Environmental Law and policy in collaboration with national and international stakeholders including law firms, corporate houses, government departments, public sector undertakings, funding agencies etc. It also plans and conducts training and extension activities such as workshops, seminars, round-table conferences etc and contributes towards ensuring that MNLU Mumbai achieves knowledge and research excellence world-wide in Environmental Law and policy.

### **Centre for Training & Research in Commercial Regulations (CTRRCR)**

CTRRCR provides a forum for discussion, training and research in the field of Commercial Laws and allied areas. The objective of the Centre is to provide an environment of debate, discussion, research and training in Corporate Law and the areas intertwined with it by bringing together academicians, professionals, legal experts, economists, regulators, judges and students and to encourage discussions, debates & spreading awareness about the contemporary changes & challenges faced by different business institutions in Indian & International Market.

### **Centre for Research in Intellectual Property (CRIP)**

CRIP's main objective is to lead research and promote well-informed interdisciplinary work in the area of intellectual property law, policy and practice through rigorous academic research, conducting seminars, workshops and conferences. The Centre also aims to bring together a group of legal academics, policymakers and industrial experts already recognised for their historical and interdisciplinary vigor.

### **Centre for Women, Child Rights And Gender Justice (CWCRGJ)**

CWCRGJ is focused on promoting and strengthening the existing knowledge on 'Rights of Women in Indian/Global Perspective' in order to address current and future challenges through introducing

curriculum-based research and practical training projects. The Centre also thrives to collaborate with National and International organizations to redress the concerns and grievances of women and develop collaborative programs and projects for the cause of women, law and justice.

### **Centre for Insolvency and Financial Laws (CIFL)**

CIFL aims to act as a think-tank in furtherance of the principal objective of raising awareness about financial laws in theory and practice, as well as conducting high-quality research in the field to assist policymakers. CIFL aims to advise and analyze the current policy approaches to insolvency and financial laws, as well as advocate for insolvency and financial law reforms and policy implementation. The Centre focuses on a multi-disciplinary approach to identify any lacunas and shortcomings present in the current conception of insolvency and financial laws. CIFL also engages in research and dialogue to facilitate systemic changes in the field.

### **Centre for Research in Air & Space Law (CRASL)**

CRASL is focused on serving as a forum for the exchange of ideas on various international laws applicable to implementing international air and space law and aims to help students engage in improving the existing legal and policy framework for facilitation and regulation of a safe, secure and sustainable space. The objective of the Centre is to contribute to the development of air and space law and related policy by conducting and promoting research and teaching at the graduate and postgraduate

### **Centre for Advanced Legal Studies, Training and Research(CALSTR)**

CALSTR is established at the Maharashtra National Law University with the goal of unifying all academic, research, and training initiatives related to past, present, and future legal issues into a single, distinct, and autonomous department.

The Centre functions with three main objectives:

1. Advanced Legal Studies
2. Legal Training
3. Legal Research

### **Centre for Research In Criminal Justice (CRCJ)**

CRCJ was founded to encourage and enhance scholarly work in the fields of criminal law and justice, criminology, victimology, and human rights on a national and international scale. The key objective of the centre is to carry out coordinated research into the efficacy and adequacy of the Criminal Justice System in India and communicate the findings and recommendations to the agencies of the Government concerned with the same.

### **Law, Humanities and Social Sciences Collective**

The Law, Humanities and Social Sciences Collective at MNLU Mumbai offers a platform to bring together research at the intersection of law and economics, literature, political science and sociology. As part of this effort, the Collective runs a blog that hosts socio-legal studies anchored in the Indian context. That apart, it houses resources tailored to help identify questions and topics for research in social sciences with reference to law. In recent months, the Collective has collaborated with Eklavya, a social service provider, to train CLAT aspirants from marginalised communities. Its members specialize in skills of interpretation, editing, drafting, curriculum and web design and outreach.

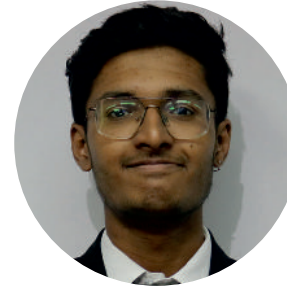

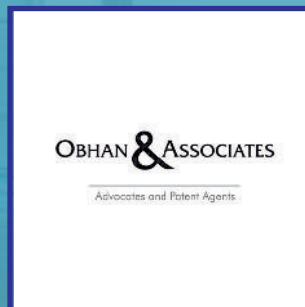
