2. Candidates who have appeared for CLAT 2021 and are desirous of taking admission in B.A.,LL.B. (Hons.) and LL.M. programmes at MNLU Mumbai under vacant categories should make an application in the above mentioned proforma [**Annexure A**] expressing their interest in seeking admission for the academic year 2021-22. Copies of following documents shall accompany the application:
 - i. CLAT 2021 Score Card.
 - ii. 12th Mark Sheet (for B.A., LL.B.) and LL.B. (all mark sheets plus degree) for LL.M.
 - iii. Maharashtra State Domicile Certificate (if applicable).
 - iv. Maharashtra Caste Certificate along with Non-Creamy Layer Certificate. Non Creamy Layer certificate is not required for candidates belonging to MH-SC and MH-ST categories.
 - v. Application fees receipt.
3. All the documents must be uploaded in the form of a single PDF.
4. Candidates are requested to pay prescribed fee of Rs. 1,000/- per application through electronic bank transfer NEFT/RTGS towards application processing fees.
