PUNISHMENTS FOR USE UNFAIR MEANS IN THE EXAMINATION

Sl. No	Nature of UFM	Punishment
1	Possessing copying material, mobile phones, smart watches or any other electronic gadget.	Removing the student from exam hall and annulment of the performance of that subject.
2	Actual copying form copying material indicated above	Removing the student from exam hall and annulment of the performance of that subject.
3	Keeping copying material as indicated above anywhere in the exam premises and accessing it under the garb of washroom break or some other pretext	Removing the student from exam hall and annulment of the performance of that subject.
4	Talking with another student(s)	Removing the student from exam hall and annulment of the performance of that subject.
5	Possession of another students answer book	Annulment of the performance of that subjects of BOTH students
6	Mutual mass copying	Annulment of the performance of all subjects and exclusion of all student involved in mass copy from another two examinations
7	Smuggling in or smuggling out blank answer book as copy material	Annulment of the performance in all subjects and exclusion of all those student from another two examinations
8	Smuggling in of the solved/written answer book based on the question paper	Annulment of the performance in all subjects and exclusion of all those student from another two examinations
9	Smuggling in of the solved/written answer book and forging signature of the exam supervisor	Annulment of the performance in all subjects and exclusion of all those student from another two examinations
10	Attempt to forge signature of the exam supervisor on answer book	Annulment of the performance in all subjects and exclusion of all those student from another two examinations
11	Interfering with or counterfeiting the seal, stamp or other stationary used for examination	Annulment of the performance in full and expulsion from University

12	Interfering in the conduct of examination by picking quarrel with the exam supervisor or any member involved in the examination duty	Annulment of the performance in full and exclusion of all those student from another two examinations
14	Insertion of additional answer book which is written outside the exam hall	Annulment of the performance in full in that subject and exclusion of all those student from another two examinations
15	Insertion of currency notes in answer book or attempting to bribe any person involved in the work of examination	Annulment of the performance in full in that subject and exclusion of all those student from another two examinations (Note: This money shall be credited to University account as income)
16	Using obscene or threatening language	Annulment of the performance in full in that subject and exclusion of all those student from another two examinations
17	Impersonation	Annulment of the performance in full in all subject and expulsion from the University
19	Revealing identity in any form	Annulment of the performance in full in that subject
20	Writing on palm or any part of the body or on cloths	Annulment of the performance in full in that subject
21	Any other malpractice not included above	Annulment of the performance in full in that subject and severe punishment depending on gravity of the act.
